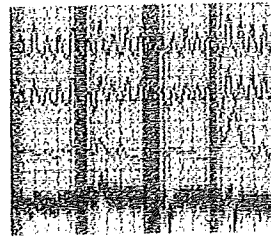

Note = The word "Girl" is defined and understood as being a unknown robbery/assault victim in questions #1 & #2, the word "Girl" is defined and understood as being the homicide victim Michelle Lai in questions #3 & #4.
