3 (The witness was sworn.)

4 HOLLY LAI,

5 called as a witness, having been

6 first duly sworn, was examined

7 and testified as follows:

8 DIRECT EXAMINATION

9 BY MR. DAIDONE:

10 Q. Nice loud, clear voice. Can you tell
11 everyone your name?

12 A. Holly Lai.

13 Q. Can you spell your first name?

14 A. H-o-l-l-y.

15 Q. Can you spell your last name for the
16 Court?

17 A. L-a-i.

18 Q. You've got to keep your voice up so

11 do?

13 Q. Okay.

14 A. Some of them ran up between the apartment
15 buildings.

16 Q. Kellie say anything to anyone?

17 A. Nobody said anything to us, they just
18 ran.

19 Q. Did you see Kellie take anything off of
20 anyone?

21 A. Yes, necklaces. Candy's necklace --

22 Q. You saw her actually take the -- remove
23 the necklace from --

24 A. I seen her trying to get it off of Candy
25 when she was fighting her.

1 Q. Did she actually take it? That was my
2 question.

3 A. Did she actually take it?

4 Q. Yes.

5 A. Yes.

6 Q. She got it?

7 A. Yes.

8 Q. Okay, what else did you see her take?

9 A. I think she took my sister's necklace.

10 That was what she was trying to get it off if her, in
11 fact I know she took my sister's necklace.

12 Q. You know that for a fact, you saw her do
13 that?

14 A. Yes, because my sister wouldn't fight
15 back. All that she did was cover her face. I see her
16 hitting her and trying to take her necklace.

17 Q. Was anyone else hitting on --

18 A. My sister?

19 Q. Yes.

20 A. No.

21 Q. Just Kellie?

22 A. Yes.

23 Q. Kellie was the only one at the car door?

24 A. Hitting my sister.

25 Q. Okay. The other day, last Tuesday, I
